SINCE 2011, OUR 12,000 SQ FT STUDIO HAS BEEN A VALUABLE RESOURCE FOR CERAMIC ARTISTS IN OUR AREA AND, INCREASINGLY, A PLACE FOR THOSE NEW TO CERAMICS TO LEARN BASIC SKILLS TO DEVELOP THEIR WORK AND STYLE.AMOCA'S ARTIST IN RESIDENCE PROGRAM, ESTABLISHED IN 2012, OFFERS ONE OF THE FEW LONG-TERM FELLOWSHIP OPPORTUNITIES ON THE WEST COAST. THE PROGRAM PROVIDES STUDIO SPACE, HOUSING FOR LONG-TERM RESIDENTS, MATERIALS, FIRING, AND LIVING STIPENDS. IN 2022, AN ADDITIONAL 6-MONTH RESIDENCY BECAME AVAILABLE FOR ARTISTS BASED IN SOUTHERN CALIFORNIA. RESIDENTS ARE SELECTED BASED ON THE QUALITY AND ARTISTIC MERIT OF THEIR WORK AND THE STRENGTH OF THEIR RESIDENCY PLAN.ARTIST WORKSHOPS, SKILL-BUILDING WORKSHOPS, AND DEMONSTRATIONS INVITE PROFESSIONAL ARTISTS INTO THE AMOCA STUDIO TO SHARE SIGNATURE TECHNIQUES AND APPROACHES WHILE GIVING OUR COMMUNITY A CHANCE TO FOCUS ON AND EXPAND THEIR PRACTICE. WE ACCOMMODATE WEEKLY COMMUNITY FIRINGS AND 200+ PRIVATE FIRINGS PER YEAR. MONTHLY INTRODUCTORY CLASSES FOR ADULTS 18+ ALLOW NEW CERAMICISTS TO LEARN THE BASICS OF THROWING ON THE POTTER'S WHEEL, INCLUDING CLAY, GLAZE, AND FIRING SERVICES. SIX-WEEK CLASSES, OFFERED QUARTERLY, INCLUDE INSTRUCTION IN WHEEL-THROWING AND HAND-BUILDING FOR NEW AND SEASONED ARTISTS TO DEVELOP THEIR SKILLS. STUDENTS ENJOY ACCESS TO OPEN STUDIO HOURS DURING THE DURATION OF THEIR COURSE.AMOCA'S CERAMICS STUDIO RENTALS ACCOMMODATE AROUND 65 SOUTHERN CALIFORNIA ARTISTS. INDIVIDUALS RENTING ONE OF 52 PRIVATE OR SEMI-PRIVATE STUDIOS RECEIVE 24/7 ACCESS TO STUDIO FACILITIES (INCLUDING A COMMUNAL GLAZE AREA, SPRAY BOOTHS, SAND-BLASTING EQUIPMENT, AND COMMUNAL FIRING SERVICES). THE STUDIO SCHOLARSHIP FUND, LAUNCHED IN 2024, ENSURES THAT ALL COMMUNITY MEMBERS HAVE ACCESS TO OUR PROGRAMS, NO MATTER THEIR FINANCIAL SITUATION.
